### WEST DUNBARTONSHIRE LEISURE GUIDE TO INFORMATION AVAILABLE THROUGH THE MODEL PUBLICATION SCHEME 2017

The Freedom of Information (Scotland) Act 2002 (the Act) requires Scottish public authorities to adopt and maintain a publication scheme which has the approval of the Scottish Information Commissioner, and publish information in accordance with that scheme. The publication scheme must:

- publish the classes of information that the authority makes routinely available
- tell the public how to access the information and whether information is available free of charge or on payment.

West Dunbartonshire Leisure has adopted the **Model Publication Scheme 2017** which has been produced and approved by the Scottish Information Commissioner. It is approved until 31 May 2021.

The purpose of this Guide to Information is to:-

- allow you to see what information is available (and what is not available) in relation to each class.
- state what charges may be applied.
- explain how you can find the information easily.
- provide contact details for enquiries and to get help with accessing the information.
- explain how to request information we hold that has not been published.

### Availability and formats

The information we publish through the model scheme is, wherever possible, available on our website. We offer alternative arrangements for people who do not want to, or cannot, access the information online or by inspection at our premises.

For example, we can usually arrange to send information to you in paper copy (although there may be a charge for this).

All our written information can also be made available, on request, in a range of different formats and languages.

### Exempt information

We will publish the information we hold that falls within the classes of information below. If a document contains information that is exempt under Scotland's freedom of information laws (for example sensitive personal information or a trade secret), we may remove or redact the information before publication but we will explain why.

### Copyriaht

West Dunbartonshire Leisure holds the copyright for the vast majority of information in this publication scheme. Where West Dunbartonshire Leisure holds the copyright in its published information, the information may be copied or reproduced without formal permission, provided that:-

- it is copied or reproduced accurately;
- it is not used in a misleading context; and
- the source of the material is identified.

Where West Dunbartonshire Leisure does not hold the copyright in information we publish, we will make this clear.

### Charges

This section explains when we may make a charge for our publications and how any charge will be calculated.

There is no charge to view information on our website or at our premises or where it can be sent to you electronically by email. We may charge for providing information to you e.g. photocopying and postage, but we will charge you no more than it actually costs us to do so. We will always tell you what the cost is before providing the information to you.

For photocopying, we will charge a standard rate of 10p per A4 side of paper (black and white copy) and 30p per A4 side of paper (colour copy).

Information provided on CD-Rom will be charged at £1.00 per computer disc. Postage costs will be recharged at the rate we pay to send the information to you.

If providing copies of any pre-printed publications, we will charge no more than the cost per copy of the total print run. We do not pass any other costs on to you in relation to our published information. We do charge in relation to information not published under this scheme. Each publication will be charged, per copy, according to how much it actually cost the West Dunbartonshire Leisure to have them professionally printed.
